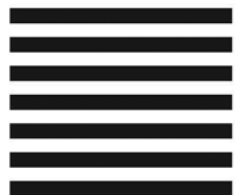

# Why Do New Yorkers Need “A Roe Of Our Own?”

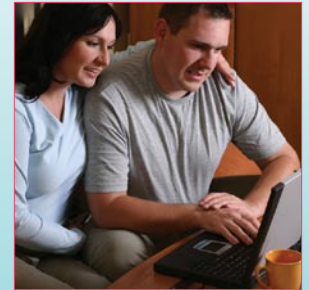


“To keep private medical decisions PRIVATE.”
